

**AMENDMENT TO THE BYLAWS OF
BRAYS VILLAGE EAST HOMEOWNERS ASSOCIATION, INC.**

I, Rosario Aguilar, Secretary of Brays Village East Homeowners Association, Inc. ("Association"), do hereby certify that at a meeting of the Members of the Association, duly called and held on the 14th day of January 2016, with at least a quorum of the Members being present and remaining throughout, and being duly authorized to transact business, the following amendment to the Bylaws of the Association was duly approved by a majority vote of the Members of the Association:

RECITALS:

1. Article XIII, Section 1 of the Bylaws, entitled "Amendments" provides the following:

"These By-Laws may be amended, at a regular or special meeting of the members, by a vote of a majority of a quorum of members present in person or by proxy, except that the Federal Housing Administration or the Veterans Administration shall have the right to veto amendments while there is Class B membership."
2. Article III, Section 2 of the Declarations of Covenants, Conditions and Restrictions for the Association declares Class B member to be the Declarant.
3. There is no longer Class B membership because the period for Declarant's control has expired.

AMENDMENT:

The Board of Directors and the Members of the Association hereby amend the Bylaws of the Association as follows:

1. Article IV, Section 1 of the Bylaws is hereby amended to read as follows:

"Section 1. Number. The affairs of this Association shall be managed by a Board of five (5) directors, who shall be members of the Association."

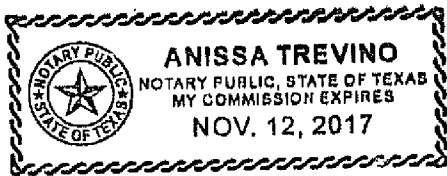
